SATURDAY OCTOBER 17TH, 2026 | 9:00AM - 2:30PM

The Berrien County 2026 Harvest Festival is presented by Nashville Main Street and Berrien County Chamber of Commerce in Historic Downtown Nashville, Georgia.

1. **Early bird fee is \$60 per space. Must be received by August 31st. Vendor fee becomes \$75 per space after August 31st. ALL vendor fees and contracts are due on or before September 30th.** *Please make checks payable to Berrien County Harvest Festival.
2. Upon arrival, vendors must check in at the Main Street booth located on the corner of S Davis Street and W Washington Avenue between 6 AM and 7:30 AM to receive space assignments and further instructions. You will be notified by email or phone if we do an early check-in on Friday, October 16th.
3. Vendors must be set up and ready to serve promptly by 8:30 AM and will remain open until 2:30 PM in the afternoon. No early breakdowns will be allowed.
4. **No trailers or trucks will be allowed in the exhibit area after 8:00am. Please allow ample time to arrive and get set up.**
5. Merchandise vendor spaces are 12' deep x 10' wide. **Free-standing tents, tables, chairs, displays, merchandise, etc., must fit within your booth space. NOTHING IS TO EXTEND BEYOND YOUR VENDOR SPACE.**
6. Vendors must have their own tents, tables, chairs, displays, and any other needed items to man their booth. **Electricity is very limited and will be first come first serve. If you need to use a generator it must be gas powered and less than 60 db.**
7. Merchandise vendors may not sell food items or bottled water from their booths. Vendors with prepackaged food items only are permitted on a very limited space availability.
8. Upon leaving the festival, be sure that you have disposed of any empty boxes, trash, etc., by placing the items in a trash can or beside the trash can by 4 PM.
9. No refunds will be issued in the event of rain or inclement weather.
10. Please include a picture of what you will be exhibiting when returning the application. Exhibitors agree to allow the sponsors to use pictures for promotional purposes.
11. The committee reserves the right to reject any application.
